At the UN International Criminal Tribunal for Rwanda Nina was a legal adviser to international judges on numerous trials in which members of the Rwandan establishment were tried for genocide. She also worked in the defence office at the Bosnian War Crimes Chamber. Domestically Nina defends and prosecutes in the Crown Court. She brings her wealth of experience internationally to bear on her UK cases where she routinely achieves excellent results for her clients.

Alongside court work Nina undertakes a wide variety of consultancies providing specialist advice to clients including governments, international and multilateral organisations, NGOs and individuals.

### Crime

Nina defends and prosecutes, appearing regularly in the Crown Courts of London and the South East of England. Recent work includes offences of serious violence including s.18 OAP, sexual offences, arson, perverting the course of justice, fraud, dishonesty, weapons, drugs, robbery, public disorder and driving. Nina also assisted lead defence counsel, Edmund Vickers,

in the first ever prosecution of FGM in the UK. Nina also accepts instructions in all areas of extradition.

Nina is a very able and intelligent barrister who is hard working and personable. She is a persuasive advocate both before juries and judges and an excellent legal draftswoman. A significant number of her cases have involved representing young and/or vulnerable clients with mental health issues and her maturity and experience have enabled her to re-assure them and ensure their best evidence. # International Representation

Nina has practiced extensively at several of the international criminal tribunals as a prosecutor and legal adviser, specifically at the Special Court for Sierra Leone, the UN International Criminal Tribunal for Rwanda and the War Crimes Chamber of the Court of Bosnia and Herzegovina on a number of high profile cases. Additionally, Nina holds a masters' degree in international public law from the London School of Economics. Nina is a chapter author in the forthcoming edition of the leading practitioner textbook on international criminal law Blackstone's International Criminal Practice, (OUP).

Nina is recognised as an expert on sexual and gender based violence crimes and has been appointed and deployed by the UK Foreign Office as a member of its team of experts on preventing sexual violence in conflict. She has also been appointed by the UK Government's Stabilisation Unit as a justice expert in post-conflict and fragile states.

Prosecution appeals counsel in the case of Charles Taylor, the former president of Liberia. # **United Nations International Criminal Tribunal for Rwanda (2007-2011)**

Legal adviser to international judges including the Tribunal President and Vice President in numerous trials including:

The Prosecutor v. Bizimungu et. al.

Four ministers in the Rwandan Government acquitted of genocide, war crimes and crimes against humanity.

The Prosecutor v. Nchamihigo

Nchamihigo, a deputy prosecutor, was convicted of instigating, ordering and aiding and abetting genocide, and crimes against humanity.

The Prosecutor v. Bikindi

Bikindi, a Rwandan singer, was convicted of direct and public incitement to genocide arising from hate speech.

The Prosecutor v. Dominique Ntawukuliyayo

Ntawukilyayo, a regional politician, was convicted of aiding and abetting and ordering

genocide.

The Prosecutor v. Gatete

Gatete, a regional politician, was convicted of genocide and crimes against humanity.

The Prosecutor v. Munyakazi & The Prosecutor v. Kayishema

In these two cases, the Chamber denied the prosecution's application to extradite the accused to Rwanda on the basis that they would not face a fair trial. These decisions were subsequently relied on by the English High Court in extradition proceedings in Bajinya et. al v.
