#### SENTENCING & CONFISCATION

**Meaning of "Disproportionate" in s6(5) POCA:** obtaining 14 years employment with false/misleading statements: appraised as strong and outstanding. SC gave credit for services rendered but profit calculated on difference between higher earning as result of fraud and earnings as if no fraud. Original confiscation order on proportionate basis: <u>Andrews</u> [2022] UKSC 24.

**Cheating the Public Revenue:** The guidelines include intended loss: the fact that events subsequently occurred whereby D could claim there would have been no real loss because same value of relief by a different means was now available, was immaterial: **Sodhi** [2021] EWCA Crim 2011.
