NEWS

DAVID YOUNG

 Defended a lorry driver unanimously acquitted of attempted facilitation under the Immigration Act 1971, having fallen victim to immigrants concealing themselves in his lorry.

STEVEN BALL

• Prosecuted an on-line grooming case where the defendant was jailed for life for violently raping and sexually assaulting three young victims.

BETHAN ROGERS

- Represented a defendant acquitted of rape and non-sexual violence. The case involved three years of text messages and extensive legal argument over bad character evidence.
- Acquittals in a case of alleged sexual abuse among siblings, with difficult legal argument concerning s.41 of the YJCEA 1999 and nondefendant bad character.

ANEURIN BREWER

- Represented a defendant acquitted of two counts of sexual abuse of a 10-year-old child.
- Reduced the period of disqualification from driving of a defendant sentenced six years before on the basis of his early release from prison, appointed by the Registrar of the Court of Appeal.
- Appeared on behalf of a defendant acquitted in a case involving the shooting of a home in a dispute between criminal groups.
- Represented a defendant acquitted of three counts of attempted murder on the basis of psychiatric evidence, after he drove his car at three schoolchildren.
- Represented a defendant acquitted in under two hours of repeatedly sexually assaulting a house guest.

GENEVIEVE REED

- Successful application to dismiss two counts alleging s.18 stabbings against the defendant's ex-partner.
- Represented a defendant acquitted of s.18 using a metal pole.
- Represented a defendant acquitted of s.18 with a baseball bat and pickaxe.
- Appeared in three separate trials where each defendant was acquitted of allegations of rape and assault by penetration.
- Represented a defendant who was acquitted of sexually abusing his 6-year-old daughter.
- Secured the acquittal of a well-known musician

charged with dangerous dog-related offences, after two adults sustained serious injuries from dogs identified as pit bull types.

ANITA CLIFFORD

 Drafted submissions that led to the removal of a client's past fraud conviction and summary from the World Check database, restoring their ability to open business bank accounts.

ANDREW HERD

- Represented a defendant acquitted in a complex conspiracy case involving approximately £1 million in stolen property.
- Represented a major food manufacturing business (with a turnover of over £150 million) in an environmental prosecution, resulting in a significantly reduced fine.
- Prosecuted a high-profile multiple wounding case at a central London hotel, with the defendant convicted of s.18.

HANNAH WILLIAMS

- Defended a person acquitted of rape, sexual activity with a child and witness intimidation. The allegations dated back to 2010 and 2011.
- Defended in contested POCA proceedings involving an application for a confiscation order of about £100,000. Following argument, the final confiscation order was made at just over £1,000.

FRANCESCA KIRBY

 Defended a person unanimously acquitted following charges of controlling and coercive behaviour, intentional non-fatal strangulation and assault by beating.

NICHOLAS HALL

 Represented a person charged with inflicting cruelty to a child in the form of sustained violence and neglect. After two hours of deliberation, the jury unanimously acquitted the client.

KATIE BACON

- Defended a person charged with assaulting an emergency worker and assault by beating; acquitted after the officer conceded an alternative cause of injury and self-defence was raised.
- Represented a person who received a suspended sentence order, following two dwelling burglaries and two thefts at the home of businesswoman, Karren Brady.

THEODORE BURGES

 In his first Crown Court trial since becoming a tenant, he represented a person acquitted of strangulation, assault and multiple thefts.
